**PETITION FOR REVIEW**

Pursuant to section 307(b)(1) of the Clean Air Act (“CAA”), 42 U.S.C. § 7607(b)(1), and Federal Rule of Appellate Procedure 15(a), Alabama Power Company, Georgia Power Company, Gulf Power Company, Mississippi Power Company, and Southern Power Company (collectively, “Petitioners”) hereby petition this Court to review the final action of the Respondent United States Environmental Protection Agency in promulgating the final rule entitled *Standards of Performance for Greenhouse Gas Emissions from New, Modified, and Reconstructed Stationary Sources: Electric Utility Generation*, published in the Federal Register at 80 Fed. Reg. 64,510 on October 23, 2015 (“Final Rule”). This

petition for review is timely filed within 60 days of the date of publication in the Federal Register. 42 U.S.C. § 7607(b)(1).




**RULE 26.1 CERTIFICATE OF CORPORATE DISCLOSURE**


